

I look forward to working with you and your child during my time here, and I will make every effort possible to work with your family in order to meet your child's needs.

I grew up in Milwaukee, WI, received my bachelor's degree in Family Studies from the University of Wisconsin Stevens Point, moved to Appleton, and soon after obtained my school counseling master's degree through the University of Wisconsin Oshkosh. The school counseling program at Tigerton Elementary and Middle School is based on the American School Counseling Association Model and our district standards. #### **NOTICE—SCHOOL LUNCH AND MILK PRICES**

Breakfast and lunch are free of charge for all students at this time through December 31 or until federal funds run out. At that time we will follow the pricing listed on this page. At that time, those that qualify for free pricing will remain free, reduced qualified families will be charged \$0.40, and student payers will be charged \$2.30 or \$2.75 respectively. Snack milk is now paid for on a daily basis from your food service account; \$0.40 per serving. Students qualifying for free or reduced priced meals will receive snack milk at no cost.

The district encourages <u>EVERYONE</u> to fill out a <u>CON-FIDENTIAL</u> free/reduced lunch application and turn it in to the elementary, high school or district office.

# **Unpaid Meal Charges Policy**

#### 8520 - Unpaid Meal Charges

This policy is to establish procedures for students and staff with insufficient funds for school meals. According to the USDA, students who are eligible for free meals <u>must</u> be provided a meal even if the student owes money. Other students must also be provided a meal if they have the money in hand to pay for the current day's meal regardless of food service account status. USDA regulations do allow other students to be denied a meal if their account is negative and they do not have the money in hand for the current day's meal. The School District of Tigerton follows a prepay policy and asks that all monies be paid in advance of meal service.

#### **How to Add Money to Student/Family Meal Plan:**

Families may add money to their food service account balance by sending cash or check to the elementary or high school office which will be deposited into their account.

#### **Unpaid Meal Procedures—Student/Family:**

- Unless parents or guardians have opted out, they will receive daily emails in regards to their child's/ family's account balance. Parents and guardians are responsible for paying in advance for their child's/family's account.
- When the student/family account reaches -\$15.00 they will be contacted by the district office by phone. The office will contact the parent/guardian a total of three times by phone. The fourth time a letter will be sent to the home.
- Students or families that fall below -\$15.00 will not be allowed to participate in any ala carte items, seconds servings, second lunches, or additional milk.
- Students with free eligibility status will not be denied a lunch, but will not be allowed ala carte items, seconds, second meals, or additional milk.
- Students with a negative balance will be provided an alternate lunch consisting of a peanut butter and jelly sandwich, fruit, and milk, and will be charged \$1.50 to their student/family account. In order to avoid undue stress on the students, if they are receiving and alternate lunch, it will be communicated to them ahead of time and will be ready for pick up in the kitchen.
- Alternate lunch will be provided for up to 15 school days. At that time, if sufficient funds have not been paid, or the parent/guardian has not made some type of arrangement with the district office, lunches will no longer be provided. Parents will be informed of this by a letter to the home.
- All school district employees are considered mandatory child welfare reporters. Parents or guardians
  must ensure their child has access to adequate food and nutrition or the funds to do so. If a district
  employee suspects that a parent's or guardian's actions or inactions cause a failure, refusal, or inability to provide adequate food and nutrition, the employee may conclude that he/she is required to file a
  report with child protective services.

#### **Unpaid Meal Procedures—Staff:**

- Staff will receive an email from Skyward weekly on their account status.
- Any negative balance must be paid immediately.
- If a balance reaches -\$15.00, they will not be allowed to purchase lunch until the negative balance is paid in full.

#### **Communication of the Policy to Families:**

- This policy shall be provided in writing (i.e. mail, email, back-to-school packet, student handbook, etc.) to: all households at or before the start of each school year; students and families who transfer into the school district, at the time of enrollment; and all school district personnel who are responsible for enforcing this policy.
- The school district may post the policy on the school district's website, in addition to providing the required written notification described above.

The Tigerton School District acknowledges that students, specifically K-8, have no control over their personal lunch accounts. In the event a student with a negative balance does receive a NSLP (National School Lunch Program) lunch it will not be thrown away for their inability to pay or money being owed. No student will be publicly identified in regards to their meal debt. Those students will not be required to "work" for their lunch or pay off a debt. All communications in K-8 will be directed specifically to the parent or guardian, not the student.

The School District of Tigerton also acknowledges that the taxpayers need to be protected and will make a reasonable effort to collect all delinquent food service debts. Any unpaid debts will carry over to the following school year until the time of graduation. Graduating seniors must have their account paid in full before participating in the graduation ceremonies.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing, or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.

## Notes from the School Nurse

#### **MEDICATIONS AT SCHOOL**

#### **Medications:**

Giving necessary medications to students at school is an important part of what I supervise for your school district. Our staff is happy to work with parents to be sure that medications are given correctly and safely. Here is a sampling of typical medications that may be necessary:

- Daily oral tablets for specific medical conditions
- Short term oral tablets, such as antibiotics or pain medication, for specific brief health conditions
- Inhalers and nasal sprays
- Eye drops
- Topical creams prescribed for specific skin conditions
- Insulin injections for diabetes
- Epipens (epinephrine injection) for severe allergic reactions
- Diastat for prolonged seizures

Keep us informed about medications that your child may need during the school day. We will ask you to complete a form, and will assist you to obtain a signed medical authorization for medication if it has been prescribed by a doctor or clinic provider. Most medications are kept in a secure location in the school office, with a few exceptions such as asthma inhalers for older students.

#### Immunizations:

Most students need additional immunizations when they enter kindergarten and again when they enter 6th grade. Please obtain these immunizations before the start of the new school year. Call your healthcare provider or the Shawano-Menominee County Health Department for additional information.

#### **Eating & Feeding Restrictions:**

This form has been included in this edition. If your child needs alternate foods at school (such as lactose-free milk, or substitute foods due to allergies, etc.) please complete this form. You can ask your doctor or clinic provider to sign it, or bring the form to school and I will send it to the provider for signature. This form helps us share information with all necessary staff and also helps food service staff with the proof needed when alternate foods must be purchased.

# CHILDREN WITH DISABILITIES AND SPECIAL DIETARY RESTRICTIONS Wisconsin Department of Public Instruction

#### A. Rehabilitation Act of 1973 and the Americans with Disabilities Act

Under Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act Amendments Act (ADAAA) of 2008, "a person with a disability" means any person who has a physical or mental impairment which substantially limits one or more major life activities or major bodily functions, has a record of such an impairment, or is regarded as having such an impairment.

Major life activities include, but are not limited to, caring for oneself, performing manual tasks, seeing, hearing, eating, sleeping, walking, standing, lifting, bending, speaking, breathing, learning, reading, concentrating, thinking, communicating, and working. A major life activity also includes the operation of a major bodily function, including but not limited to, functions of the immune system, normal cell growth, digestive, bowel, bladder, neurological, brain, respiratory, circulatory, endocrine, and reproductive functions.

#### B. Individuals with Disabilities Education Act

A child with a "disability" under Part B of the Individuals with Disabilities Education Act (IDEA) is described as a child evaluated in accordance with IDEA as having one or more of the recognized thirteen disability categories and who, by reason thereof, needs special education and related services. The IDEA can be found in its entirety at <a href="http://nichcy.org/wp-content/uploads/docs/IDEA2004regulations.pdf">http://nichcy.org/wp-content/uploads/docs/IDEA2004regulations.pdf</a>.

The Individualized Education Program (IEP) is a written statement for a child with a disability that is developed, reviewed, and revised in accordance with the IDEA and its implementing regulations. When nutrition services are required under a child's IEP, school officials need to make sure that school food service staff is involved early in decisions regarding special meals. If an IEP or 504 plan contain the same information that is required on a medical statement, then it is not necessary to get a separate medical statement from a licensed medical practitioner.

#### C. Licensed Medical Practitioner's Statement for Children with Disabilities

U.S. Department of Agriculture (USDA) regulations 7 CFR Part 15b require substitutions or modifications in school meals for children whose disabilities restrict their diets. School food authorities must provide modifications for children with disabilities on a case-by-case basis when requests are supported by a written statement from a state licensed medical practitioner.

The licensed medical practitioner's statement must identify:

- an explanation of how the child's physical or mental impairment restricts the child's diet;
- · the food(s) to be avoided; and
- the food or choice of foods that must be substituted.

The second page of this document ("Medical Statement for Special Dietary Needs") may be used to obtain the required information from the licensed medical practitioner.

"Practitioner" is defined by Wisconsin State Statute 118.29(1) (e): "Practitioner" means any physician, dentist, optometrist, physician assistant, advanced practice nurse prescriber, or podiatrist licensed in any state. If the documentation to support a dietary accommodation has not been signed by one of these practitioners, the school is not required to accommodate the request (unless information about the dietary need is included within the IEP or 504 plan, as mentioned above in Section B.)

#### D. Substitutions Within the Meal Pattern

It is strongly recommended, though not required, that schools have documentation on file from any medical authority for students with dietary needs for whom they are making menu modifications within the meal pattern. Such determinations are only made on a case-by-case basis and all accommodations must be made according to USDA's meal pattern requirements.

Dear Parent/Guardian,

Per Wisconsin State Statute, we are providing information on the importance of immunizations for your child against a potentially fatal bacterial infection called Meningococcal Disease, a type of Meningitis.

#### About Meningococcal Disease

Meningococcal disease can be misdiagnosed as early symptoms may be high fever, severe headache, nausea, vomiting, and a stiff neck which are similar to common viral illnesses. The disease progresses rapidly and can lead to brain damage, loss of hearing, and death within 24 to 48 hours. Adolescents are at a greater risk for meningococcal disease, accounting for 30% of all cases in the United States.

The following activities put your child at an increased risk:

- Sharing drinking glasses, bottles, straws, eating utensils, and food
- Sharing lipstick or lip balm
- Kissing
- Attending an overnight camp
- Living in a dormitory

#### Meningococcal Vaccine

Vaccination for meningococcal disease protects against the most common types of bacteria that can cause meningococcal disease. The Center of Disease Control and Prevention along with other leading medical organizations recommend the following:

Vaccination for anyone 11-18 years of age, preferably at the ages of 11 or 12. A booster vaccination between ages 16 and 18 if the first vaccination was given between the ages of 11 and 15.

#### 8510 - WELLNESS

As required by law, the Board of Education establishes the following wellness policy for the Tigerton School District as a part of a comprehensive wellness initiative.

The Board recognizes that good nutrition and regular physical activity affect the health and well-being of the District's students. Furthermore, research suggests that there is a positive correlation between a student's health and well-being and his/her ability to learn. Moreover, schools can play an important role in the developmental process by which students establish their health and nutrition habits by providing nutritious meals and snacks through the schools' meal programs, by supporting the development of good eating habits, and by promoting increased physical activity both in and out of school.

Schools alone, however, cannot develop healthy behaviors and habits in students with regard to eating and exercise. It will be necessary for not only the staff, but also parents and the public at large to be involved in a community-wide effort to promote, support, and model such healthy behaviors and habits.

The Board sets the following goals in an effort to enable students to establish good health and nutrition choices to:

- 1. promote nutrition education with the objective of improving students' health and reducing childhood obesity;
- 2. improve the health and well-being of our children, increase consumption of healthful foods during the school day, and create an environment that reinforces the development of healthy eating habits;
- 3. promote nutrition guidelines, a healthy eating environment, child nutrition programs, and food safety and security on each school campus with the objective of promoting student health and reducing childhood obesity;
- 4. provide opportunities for every student to develop the knowledge and skills for specific physical activities, maintain physical fitness, regularly participate in physical activity, and understand the short and long-term benefits of a physically active lifestyle;
- 5. promote the health and wellness of students and staff through other school based activities.

The District Administrator shall obtain the input of District stakeholders, to include parents, students, representatives of the school food authority, educational staff (including physical education teachers), school health professionals, members of the public, and other school administrators in the development, implementation, evaluation, and periodic update, if necessary, of the wellness policy.

The District Administrator is encouraged to form a wellness committee to carry out this function.

The wellness committee shall be an administrative committee with members recruited and appointed by the District Administrator.

The District Administrator shall be responsible for accomplishing the following:

- 1. assess the current environment in each of the District's schools;
- 2. measure the implementation of the District's wellness policy in each of the District's schools;
- 3. review the District's current wellness policy;
- 4. recommend revision of the policy, as necessary; and
- 5. present the wellness policy, with any necessary revisions, to the Board for approval or re-adoption if revisions are necessary.

The District Administrator will oversee development, implementation, and evaluation of the wellness procedures.

The District Administrator shall conduct reviews of the progress toward school wellness procedures, identify areas for improvement, and recommend revision of procedures as necessary.

- 1. With regard to nutrition education, the District shall:
- 2. Nutrition education shall be included in the Health curriculum so that instruction is sequential and standards-based and provides students with the knowledge, attitudes, and skills necessary to lead healthy lives.
- 3. Nutrition education shall be integrated into other subject areas of the curriculum, when appropriate, to complement, but not replace, the standards and benchmarks for health education.
- 4. Nutrition education shall extend beyond the school by engaging and involving families and the community.
- 5. Nutrition education standards and benchmarks promote the benefits of a balanced diet that includes fruits, vegetables, whole grain products, and low-fat and fat-free dairy products.
- 6. The District shall provide information to parents that is designed to encourage them to reinforce at home the standards and benchmarks being taught in the classroom.
- 1. Links with Nutrition-Related Community Service:
- 2. Grades K-4: University of Wisconsin-Extension Wisconsin Nutrition Education Program (WNEP) nutrition lessons.
- 3. Grade 4: UW Extension/FFA partnership or representative will teach Adventures in Dairyland
- 4. Others as available

#### Staff as Role Models

1. It is realized that role modeling and consistent messaging is an important part of health education. The School District encourages staff to exhibit healthy food/beverage habits during the instructional school day within the classroom.

With regard to physical activity, the District shall:

#### **Physical Education**

- 1. A sequential, comprehensive physical education program shall be provided for students in K-12 in accordance with the physical education academic content standards and benchmarks adopted by the State.
- 2. All students in grades ECE -5, including those with disabilities, special health care needs, and in alternative educational settings (to the extent consistent with the students' IEPs), shall receive instruction in physical education for at least three (3) days per week for the entire school year.
- 3. All students in grades 6 -8, including those with disabilities, special health care needs, and in alternative educational settings (to the extent consistent with the students' IEPs), shall receive instruction in physical education for at least two (2) to three (3) days per week for the entire school year.
- 4. All students, including those with disabilities, special health care needs, and in alternative educational settings (to the extent consistent with the students' IEPs), shall receive instruction in physical education for five (5) days per week for at least three (3) semesters in grades 9-12.

#### **Physical Activity**

Physical activity and movement shall be integrated, when possible, across the curricula and throughout the school day.

- 1. All students in grades ECE-5 shall be provided with a daily recess period at least thirty (30) minutes in duration. Recess shall not be used as a punish ment
- 2. All students in grades 6-12 shall have the opportunity to participate in interscholastic sports programs.
- 3. Youth Sports Programs (i.e. Little League, Softball, T-ball, Basketball) will be coordinated through the District.
- 4. Use of fitness center by community members is encouraged, will be promoted through:
  - Newspaper (Marion Advertiser)
  - Newsletter (Tiger Tribune)
  - Website links/Social Media
  - Community Postings

With regard to other school-based activities the District shall:

- 1. The schools shall provide at least fifteen (15) minutes daily for students to eat.
- 2. An organized wellness program shall be available to all staff.
- 3. Schools in our system utilize electronic identification and payment systems, therefore, eliminating any stigma or identification of students eligible to receive free and/or reduced meals.

Furthermore, with the objectives of enhancing student health and well being, and reducing childhood obesity, the following guidelines are established:

- 1. In accordance with Policy 8500, entitled Food Service, the food service program shall comply with Federal and State regulations pertaining to the selection, preparation, consumption, and disposal of food and beverages as well as to the fiscal management of the program.
- 2. As set forth in Policy 8531, entitled Free and Reduced Price Meals, the guidelines for reimbursable school meals are not less restrictive than the guide lines issued by the U.S. Department of Agriculture (USDA).
- 3. All foods sold/available on campus during the school day shall comply with the current USDA Dietary Guidelines for Americans, including competitive foods that are available to students a la carte in the dining area, from vending machines.
- 4. This policy in no way prohibits parents from providing snacks for special occasions, such as birthdays. However, families will be encouraged through take-home materials to send healthy snacks.
- 5. Food fundraisers that meet USDA Dietary Guidelines for Americans are allowed during the school day. These sales must occur outside of school break fast and lunch periods. Two (2) fundraisers that include non-exempt food items sold during the day are allowed for each group per year. Duration of these fundraisers may not exceed two (2) weeks. Administrative approval is needed prior to fundraising.
- 6. Whenever possible, accommodations should be made for a classroom allergy. The school nurse will provide a list of appropriate snacks based on said allergy at the beginning of the school year. It will be updated if/when a change occurs.

The District Administrator shall be responsible for informing the public, including parents, students, and community members, on the content and implementation of this policy. In order to inform the public, the District Administrator shall distribute information at the beginning of the school year to families of school children and post the wellness policy on the District's website, including the assessment of the implementation of the policy prepared by the District.

Review of this policy shall occur every three (3) years, by a committee appointed by the District Administrator; consisting of the administrator, the food service director, phy-ed teacher, and the public. The committee shall provide the Board with any recommended changes to this policy.

# <u>Directory Information/Student Records/</u> <u>Student Privacy</u>

(TSD Policy 2416-Student Privacy and Policy 8330-Student Records)

The School District of Tigerton maintains student records for each student attending school in the District. State and federal law require that the maintenance of such records assure confidentiality. Accordingly, only those individuals or agencies specifically authorized by state and federal law are granted access to student's records. An adult student, or the parent/ guardian of a minor student, may inspect, review and obtain copies of student records kept by the school in accordance with Board policy and established procedure. (TSD Policy #2416 and #8330). However, in accordance with the Family Educational Rights & Privacy Act and Wisconsin State Statute 188.125(1)(b) and (2) (j), the School District of Tigerton has declared the following personally identifiable information contained in a student's education records as "director date/information": a student's name; address; telephone number; date and place of birth; photograph; major field of study; participation in officially-recognized activities and sport; height and weight, if a member of an athletic team; dates of attendance; date of graduation; or degrees and awards received. Parents of eligible students may refuse to allow the Board to disclose any or all of such "directory information" upon written notification to the Board within fourteen (14) days after receipt of the District Administrator's annual public notice or enrollment of the student into the District of such enrollment occurs after the annual public notice. Any parent or eligible student who refuses to allow disclosure or directory data and who participates in extra-curricular activity must acknowledge a limitation on the refusal to disclose directory information obtained during the course of the student's participation in extra-curricular activities.

Districts receiving federal education funds are required to notify parents of secondary school students: 1. That a secondary school student or the parent of the student may request that the student's name, address and telephone listing may not be released to military recruiters or institutions of higher education without prior written parental or student consent; and 2. That the district must comply with such request. School districts receiving federal education funds are required to provide, on request made by military recruiters or an institution of higher education, access to secondary school students' names, addresses and telephone listings unless access to secondary school students' names, addresses and telephone listings unless access to such information has been restricted by the secondary school student or the student's parents as outline above. Federal guidelines issued to implement this requirement state that if a school district does not designate student names, addresses and/or telephone listings as directory date it must still provide all three items to military recruiters and institutions of higher education upon request.

# <u>Special Education Referral and Evaluation</u> <u>Procedures</u>

Upon request, the School District of Tigerton is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made. Others, including parents, who reasonably believe a child is a child with a disability may also refer the child, including a homeless child, to the school district in which the child resides. Referrals must be in writing and include the reason why the person believes the child is a child with a disability. My Horticulture students had planted some vegetable and flower seeds, started the begonia hanging baskets, and had transplanted the pansies and marigolds. Your encouraging comments in person or online, smiles, and support through monetary and plasticware all kept me going through these trying times.
